IF THE STUDENT'S NAME APPEARS IN THE MERIT LIST THE STUDENT IS REQUIRED TO FILL THE PHASE II OF THE ONLINE APPLICATION FORM BEFORE COMING FOR ADMISSIONS ON THE SPECIFIED DATES. THE PROCEDURE TO BE FOLLOWED TO FILL THE PHASE II OF THE APPLICATION FORM IS AS UNDER:

PHASE II. ADMISSION FORM (WILL BE AVAILABLE & IS TO BE FILLED BY THE CANDIDATE WHOSE NAME APPEARS IN THE MERIT LIST).

FOR FILLING THE PHASE II FORM THE CANDIDATE MUST LOGIN WITH THE SAME USER ID WITH WHICH HE/SHE HAD FILLED THE PHASE I FORM. THE CANDIDATE MUST GOTO THE LINK "CHECK THE STATUS" AND CLICK ON 'POST ADMISSION FORM LINK' TO FILL THIS FORM. IT IS MANDATORY FOR THE CANDIDATE TO FILL THIS FORM ONCE HIS /HER NAME APPEARS ON THE MERIT LIST AND BRING THE HARD COPY OF THE SAME TO THE COLLEGE AT THE TIME OF CONFIRMING THE ADMISSION BY PAYING THE FEES.

1. The Phase II (Post Admission form) contains 4 screens:
 - a. PERSONAL DETAILS: the student has to fill the required information about aadhar card, caste, blood group, permanent address, local address, marital status etc.
 - b. PARENT/GUARDIAN DETAILS: details about the parent /guardian to be entered, email id etc.
 - c. PREVIEW: This screen shall allow the student to view all the information filled by the student in Phase I and phase II of the form but changes, if any, can be made only in the Phase II form.
 - d. UPDATE: Click on the UPDATE button to submit the form.
 - e. Take the hardcopy of the form and bring it along with the original documents when you come for admission and payment of fees.

1. Hard Copy of the Phase II form along with two copies of the Pre-Admission Registration Form of University of Mumbai.
2. Original H.S.C. / Equivalent Mark Sheet and Original H.S.C. / Equivalent Leaving Certificate with 2 photocopies of the mark sheet and the Leaving Certificate **each without attestation.**
3. 2 copies of S.S.C. / Equivalent Mark Sheet **without attestation.**
4. Photo copy of Ration Card / Telephone Bill / Electricity Bill / Passport as proof of residence.
5. Photocopy of Aadhar Card / photocopy of the receipt of application of Aadhar card in case it is not yet received.
6. Any other certificate as applicable, in the name of the student depending upon the category in which he/she is taking admission.
7. 3 recent identity card size photographs.
8. 5 Self addressed envelopes with stamp of Rs. 5 pasted on the envelope.
9. Acknowledgement Token issued by the college.

Students applying under GUJARATI LINGUISTIC MINORITY must satisfy the following norms:

- 1. SHOULD BE GUJARATI BY BIRTH AND SHOULD HAVE PASSED THE H.S.C. / EQUIVALENT EXAMINATION.**
2. In case if the student is not GUJARATI by birth but the mother of the applicant is Gujarati, the marriage certificate of the parent indicating mother's name must be produced for verification.
3. In case of doubtful surnames, the parent will have to produce their 10th std. mark sheet indicating Gujarati as one of the subject at the 10th Std.
4. Certificate from the Head of the Community / Trust / institution (Government recognized) confirming the claim.

STUDENTS SEEKING ADMISSION UNDER DEFENCE, FREEDOM FIGHTERS, TRANSFER & SPORTS etc.:

- a. Certificate from Zilla Sainik Welfare Association.
- b. Copy of Tamrapatra.
- c. Govt. Transfer Order specifying date of transfer for Transfer.
- d. Photocopies of the certificates indicating achievements in sports (DSO, National/International registered and recognized organization) during the years 2015-16 & 2016-2017.

STUDENTS SEEKING ADMISSION UNDER N.R.I.:

- A valid student visa or document of PIO (person of Indian origin)/OCI.
- A permanent address or residential proof in the foreign country.
- A residential proof of the Guardian in Mumbai.
- A prima facie letter from the University of Mumbai for eligibility (for students of international boards).
- A complete body checkup profile and blood report of the student.
- Original mark sheets, transfer certificate, migration certificate, a letter from the Consulate (in case of NRI students).
